- Is not clean or has a foul odor; or
- Makes unsolicited contact with persons while on District property; or
- Poses a direct threat to the health or safety of others; or
- Is out of control and the handler does not or can not take effective action to control it; or
- Bites someone; or
- Disrupts the normal course of school business; or
- Makes unnecessary vocalizations; or
- Solicits or steals food or other items from persons while on District property; or
- Urinates or defecates in an area of District property not assigned for this purpose; or
- Does not remain in the designated area

I agree to be responsible for all damage to District property, personal property, and any injuries to individuals caused by my non-service animal. I agree to indemnify, defend and hold harmless Brevard Public Schools from and against any and all claims, actions, suits, judgments, and demands brought by any party arising on account of, or in connection with any activity of or damage caused by my non-service animal including all attorney’s fees and costs associated with defending any litigation brought regarding a non-service animal. I agree to participate in meetings regarding the student use of this non-service animal if approved.
